

AICQ SICEV - as an accredited third-party Certification Body - in collaboration with SITOX – as an Evaluation Body – has defined and activated the Certification Scheme for the Toxicologist professional figure.

WHO CAN OBTAIN THE CERTIFICATION?

This professional figure is responsible for identifying and characterizing the danger and extent of exposure to chemical agents and their metabolites in population, patients and workers, as well as identifying strategies for the control and protection of health against potential damage resulting from exposure to chemical agents of natural or synthetic origin.

The toxicologist interested in the certification can request the recognition of the following areas of competence:

- Analytical toxicology
- Biomonitoring and exposure evaluation
- Molecular, cellular toxicology
- Genotoxicity and Carcinogenicity
- Reproduction and developmental toxicology
- Clinical toxicology and advanced therapies
- Environmental toxicology
- Occupational toxicology
- Regulatory toxicology
- Forensic toxicology

SKILLS ASSESSMENT AND THEIR CERTIFICATION

The certification process takes place in front of a commission of experts that evaluates for each candidate:

- the essential **knowledge** deriving from the training and updating path
- the **skills** deriving from the acquired work experience
- the competences associated with the aforementioned knowledge and skills

The **certification process** consists of the following steps:

- a) Documentary analysis of the prerequisites
- b) Written exam (multiple choice questions)
- c) Oral exam

In the event of a positive outcome, the process ends with the certificate issue and the inclusion in the AICQ SICEV Register of competence and, once accreditation is obtained, in the ACCREDIA Register.

The professional certificate has a five-year duration, with annual verification of the maintenance of skills. The certification renewal procedures are indicated in the applicable Scheme Regulation.

REGISTRATION METHOD

To participate in the exam session, the Certification exam application must be completed on the website www.aicqsicev.it, accompanying this request with the required attachments. The application and its attachments must be sent, within 8 working days from the date scheduled for the exam session, to the email address <u>info@aicqsicev.it</u>.
